
Market is segmented into retail and wholesale Markets:

In the Retail market, in Pennsylvania, Solar Capacity is limited to 50 kW for residential services and 3 mW for Commercial services. Consumer deal with Electrical Distribution Companies, Rural Electric Cooperative, or Municipal Electric Authorities at voltages below 1,000,000 volts.

In the Wholesale market the voltages are greater than 1,000,000 volts and PJM is the governing authority. Power sales are into the market or by bilateral contract.


Wholesale vs. Retail

New Rate Design Options such as Hourly Pricing






Public Policy Will Impact Diversity






Generation Diversity Year 2030
